It is to inform all concern M/s Telesonic Networks Ltd. for laying utility is vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Dhule has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by M/s Telesonic Networks Ltd. for laying Optical Fiber Cables (OFC) along NH-03 LHS Mumbai Agra Highway from km 289.700 to km 290.000 for total length 0.300km in Dhule city along NH-03 in the State of Maharashtra. The following work is included:

- Laying of underground Optical Fiber Cable from km. 255.000 to km 255.300 on LHS.
- Cable to be laid along highway in trench in utility corridor.
- Cable to be crossed by HDD method at 255.000.


