Sub: NHAI - PIU, Kancheepuram - Request for permission to lay underground Electrical Cable along the road on NH-4 (Maduravoyal to Sriperumbudur Section) from Km 21/000 to Km 18/100 (RHS) - 2900m by Open Trench Method and diagonally across the road from KM 18/100 to Km 18/000 - 70m by Trenchless Method (HDD) for a total length of 2970m in the limits of National Highways by M/s TANTRANSCO, Chennai Development Circle -II - Approval Requested - reg

- 1. The subject proposal is requesting permission for laying of Electrical Cable along the road on NH-4 from Km 21/000 to Km 18/100 (RHS) 2900m by Open Trench Method and diagonally across the road from Km 21/000 to Km 18/100 70m by Trenchless Method (HDD) for a total length of 2970m in the Project Highway of Maduravoyal to Sriperumbudur section of NH-4 in the State of Tamil Nadu.
- 2. M/s. TANTRANSCO, Chennai Development Circle –II has furnished an undertaking to shift the utility at our own cost if required by the Department in case of widening of the road (or) any other purpose within such time as will be stipulated by the NHAI. Further, the applicant has furnished the undertaking for the payment of rent/fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R(R) dated 22.11.2016 as when asked by NHAI.
- 3. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015-S&R(R) dated 22.11.2016, the proposal submitted by M/s. TANTRANSCO, Chennai will be made available for 30days seeking public comments/Objection and shall be furnished within 30days from the day of closure of public objections.
