Aurangabad at Ch. km. 281.700 in District falling en-route Mumbai to Nagpur Pipeline in Aurangabad District. The following work is included:
 - Crossing of Gas pipeline 24" dia at Ch. 281.700 on National Highway 752I through HDD Method.
