It is to inform all concern that Bharat Gas Resources limited Aurangabad vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Aurangabad has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that Bharat Gas Resources limited Aurangabad along NH-52 on Golwadi Bypass Road, from KMS Ch. 311+355 to KMS Ch. 310+100 of District Aurangabad State of Maharashtra is as follows:

- Underground steel GAS pipeline (18") on National Highway 52 (Old NH-211) in between ch.310+100 to ch. 311+355 ( 1255 mts. ) in total length of 1255 meters along with 1 nos. Of crossings on our project highway.
- Laying Steel Gas pipeline (18"inch) in the utility corridor only i.e. within 2m from the age of the ROW and Crossing at ch. 311+355 with carried out by HDD/Push Through Method.
- GAS pipeline to be laid in Duct 1.2m below ground level in both method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
