It is to inform all concern that RO, MoRTH, Jaipur vide letter No. 3862 dated 21.10.2020 has forwarded the proposal for grant of permission for laying 33KV XLPE Elec. 

With reference to the subject cited above, the proposal submitted by Executive Engineer (Project), Ajmer Vidyut Vitran Nigam Ltd, Udaipur was forwarded to this office for necessary verification vide MoRTH letter under reference (i) above. The proposal has been examined by the Independent Engineer M/s. SA Infra letter and they have submitted the report vide letter No. 86 dated 05.09.2020 along with calculation details of rental fee payable for 70 m length, where cable crossing will be done, amounting to Rs. 1,865/-. Accordingly, this office vide letter cited (vi) above has requested to the applicant for depositing the License Fee/Lease rentals applicable as per Ministry guideline No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 through Bharatkosh Portal (www.Bharatkosh.gov.in) in the name of RPAO (Regional Pay account Officer) MoRTH, Jaipur as per MoRTH Circular dated 09.08.2018 and provide copy of the receipt of amounting to Rs. 1,865/- as per calculation sheet attached.

Subsequently, Executive Engineer (Project), AVVNL, Udaipur has submitted the following:

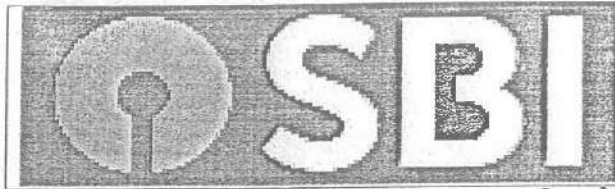

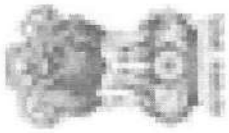
