## Notice inviting public comments in respect of Extension of Time for 'inprinciple' NOC

Sub: Proposal for grant of access permission to the proposed retail outlet by M/s.BPCL at km.64/700-745 (RHS, Survey no.363/AA) of Hyderabad-Vijayawada Section of NH-65 in Sy.No.363/AA of Gundrampalli Village, Chityal Mandal, Nalgonda District in the State of Telangana- Extension of time - Reg

In principle NOC has been issued to the above subject proposed retail outlet vide letter No MoRT&H, RO - Hyd Lr.No. RW/HYD/Misc-24/Access/RO/NH-65/5.No.197/923, dated 28.03.2018. The retail outlet was not constructed due to certain technical difficulties and it is proposed to extend the validity of the 'in-principle' NOC for Six months. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/NH-33023/19/99-DO.III dated 24.07.2013 based on justification at Annexure I.

- 2. As per Ministry vide OM No.RW/NH/33023/19/99-DO.III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.
- 3. In view of the above, the comments from public on the above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (<a href="https://www.morth.nic.in">www.morth.nic.in</a>) as per Form-A (copy enclosed).

Sir,

This has reference to the MoRTH, Hyderabad vide ref. 1st cited, wherein "In-Principle" approval has been accorded for the subject cited access permission for BPCL and informed that the construction is not done in one year (1 Year), the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Administration beyond 6 months and up to one year from the date of issue of provisional NOC for construction of acceleration lane/deceleration lanes.

- Vide ref. 2nd cited of M/s BPCL due to some reasons explained in their letter and they were unable to construct the retail outlet within one year time.
- This office vide ref. 3rd cited addressed to M/s BPCL with certain observations and requested M/s BPCL to submit the detailed explanations for taking further necessary action.

- 4. Vide ref. 4th cited of M/s BPCL has given clarification in their letter that their legal department pointed out that there is a small variation in the Sy.No.363/AA instead of 363/A the proposed site is under 'A' category and their oil company have to invest and also informed that their legal department very particular about the difference in the survey number and the same informed to dealer to get clarification from the Additional Collector. Due to continue elections of State and Central Elections, Panchayat and local body the revenue department is very busy and dealer unable to get the letter from Additional Collector within time. In meanwhile the inprinciple letter expired. Without site legal clarification and budget sanction not constructed the proposed site. M/s BPCL has informed that because of the above reason, they are unable to construct the retail outlet within the stipulated one year time. Now, M/s BPCL requested this office to accept and grant one more year extension for their "in-principle" approval.
- 5. In view of the above clarification submitted by the applicant M/s BPCL, necessary directions may please be given for the extension of time for another six months for their "in-principle" approval of above retail outlet.

Sub:- Proposal of access permission to New Retail Out let by M/s. Bharat Petroleum Corporation Limited at Km.64/700-745 (RHS) of Hyderabad to Vijayawada Section of NH-65 under Survey No.363/AA of Gundrampalli Village, Chityal Mandal, Nalgonda District in the State of Telangana-Reg.

Sir.

Please refer to your letter no. NHAI/PIU-HYD/RO/2017/152 dated 13.02.2018 submitting therewith a proposal on the above mentioned subject.

- 2. The proposal has been broadly examined on your recommendations and is accepted "in-principle" subject to the following conditions:
- (i) The issue of final formal permission including issuance of signed license deed would be subject to the certification by The Project Director, NHAI PIU-Hyderabad, that the constructions have been carried out in compliance with the provisions approved by Highway Administration. Hence it is directed to issue the completion certificate after construction of access road as per proposed layout plan along with final certified copy of layout plan duly endorsing a copy to this office.
- (ii) The validity of the provisional NOC and the subsequent final approval shall be governed as para 11 of the Ministry's circular no. RW-NH-33023/19/99-DO-III dt.24.07.2013, i.e., the Oil company/Owner should construct the fuel station/Private Property along with its access as per approved drawings at their own cost within 6 months of the issue of this provisional NOC. After the construction as per approved drawings and to the satisfaction of the Highway Administration, the final approval will be issued within 30 days of the receipt of communication from the applicant about the completion of construction work and license deed will be signed by the Competent Authority (i.e. Highway Administration). In case, the construction is not done in one year (1 year), the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Administration beyond 6 months and up to one year from the date of issue of this provisional NOC for construction of acceleration lane/deceleration lanes.
- (iii) The fresh license deed (duly indicating chainages of NH) in two originals drawn on new stamp paper as per Ministry's standard norms and duly signed by authorized signatory may also be furnished at the time of issue of final permission. However, the Retail Outlet shall not be energized before issue of final permission by the Competent Authority.

- As per Ministry's circular F.No.RW/NH-33044/05/2018/S&R(P&B) dated 18.01.2018 (iv) the toilet unit may be provided at a standalone location within the Retail Outlet premises duly equipped with lighting, water and requisite clearing accessories etc to all road users of the National Highways (with traffic signages of the availability of toilet facility along National Highways) and the toilets shall be kept open round the clock. Further, minimum size shall be adopted for both gents and ladies toilets as per said circular.
- There should be sufficient parking inside so that there is no overflow of vehicles on (v) approach roads.
- The applicant shall install all the requisite road signs as per IRC: 67 & provide road (vi) markings as per IRC: 35 in accordance with the Ministry's guidelines and to the satisfaction of the The Project Director, NHAI, PIU-Hyderabad.
- The applicant shall arrange all the clearances including forest clearance required for (vii) constructing the proposed access as per approved drawing himself. The applicant shall also arrange for shifting of utilities if required at his own cost as per the direction of the concerned department.
- It is requested, that requisite fee of Rs.2,55,256/- (Rupees Two lakhs fifty five thousand two hundred fifty six only) in favour of "Regional Pay & Accounts Officer (NH), MORTH, Hyderabad" payable at Hyderabad by the licensee to the Government of India in consideration of agreement for the land for which license is issued as indicated in Para-5 of Ministry's circular no. RW-NH-33023/19/99-DO-III dated 24.07.2013 may be deposited within 30 days from the issue of this letter, failing which the "in-principle" approval now issued is deemed to be cancelled. The license deed shall be executed only after the deposit of the said fee in Central Revenue Major Head 1054 and after completion of construction as per approved drawings and to the satisfaction of the Highway Administration.
- Notwithstanding anything in the above, paras, the Provisional NOC issued shall stand to be cancelled under the following circumstances:
- If any document/information furnished by the applicant proves to be false or if the (i) applicant is found to have will fully suppressed any information.
- Any breach of the condition imposed by the by the Highway Administration or the (ii) officer authorized by the Administration on his behalf.
- If at any later stage, any dispute arises in respect of the ownership of the land on which the fuel station is located or regarding the permission for change of land use.

#### INSPECTION REPORT

M/s. Bharat Petroleum Corporation Limited vide their letter dtd 31.07.2017 submitted proposal for NOC & access permission to their proposed Retail Outlet @ Km 64/700-745 (RHS) of Hyderabad-Vijayawada section of NH 65 and is examined.

The site is inspected and observed as under:

1. The location is @ Km 64/700 to Km 64/745 on Right Hand Side of Hyderabad-Vijayawada section of NH 65 in Gundrampalli Village, Chityal Mandal, Nalgonda District

2. The available ROW is 60 m at the proposed retail outlet location.

Inspection Report of Team Leader, M/s Sheladia Associates Inc., is also enclosed. The proposed siting of fuel station is as under:

Figures shown in the brackets are minimum distance stipulations of MORT&H for considering the access permission to the fuel stations.

The proposed fuel station is not yet commissioned and work is yet to be commenced.

The check – list and drawings are as per the guidelines issued by the MORT&H Circular No. RW/NH-33023/19/99-DI-III, dated 24.07.2013 and Subsequent amendments thus satisfies all the conditions stipulated by the Ministry.
