## National Highways Authority of India NHAI, PIU – Ramanagara Invitation of Public Comments

Sub: Permission for the laying of 66Kv, 1CX 240Sqmm power cable in trefoil manner along with OFC cable in NH-766 from Nanjanagudu 66/11 Kv Substation Km 191.190 to proposed Railway TSS Sujatapura Km 190.870 for a total route length of 320 mtr through the open cut methodology and the crossing at Km 191.190 HDD method along Kerala Border to Kollegala Section of NH-766 in the state of Karnataka -reg.
