Sub: NHAI, Madurai Region - PIU, Dindigul - Permission for laying water supply pipeline along NH from Km 223/700 to Km 269/633 (LHS) in Kumuli-Theni section of NH-220, & from Km 80/435 to Km 82/410 (RHS) in Dindigul-Theni section of NH-45(E) and crossing at Km 246/300, Km250/600 of NH-220 & Km 80/435 of NH-45(E) in the State of Tamil Nadu - Proposal submitted - Reg

The proposal is regarding permission for laying water supply pipeline along NH from Km 223/700 to Km 269/633 (LHS) in Kumuli-Theni section of NH-220, & from Km 80/435 to Km 82/410 (RHS) in Dindigul-Theni section of NH-45(E) and crossing at Km 246/300, Km250/600 of NH-220 & Km 80/435 of NH-45(E) in the State of Tamil Nadu was submitted to this office by PD, PIU Dindigul vide letter No. NHAI/PIU/DGL/11014/02/Water Pipe Line/2019/1414 dt. 21.11.2019 (received on 26.11.2019) in accordance with Ministry's latest guidelines dated 22.11.2016.

2. The alignment proposed by the Commissioner & Special Officer, Madurai Corporation, Madurai, for laying water supply pipeline along NH from Km 223/700 to Km 269/633 (LHS) in Kumuli-Theni section of NH-220, & from Km 80/435 to Km 82/410 (RHS) in Dindigul-Theni section of NH-45(E) and crossing at Km 246/300, Km250/600 of NH-220 & Km 80/435 of NH-45(E) in the State of Tamil Nadu i.e. in a length of 47908 m as detailed under:

3. The right of way is 30m & 60m (existing Road & Bypass/realigned portion respectively) in the aforesaid stretch. The Commissioner & Special Officer, Madurai Corporation, Madurai, has proposed to lay water pipe line at the extreme edge of the

ROW for a length of 47908 m. The laying of water supply pipe line is proposed to be laid at a distance more than 14.5 m from the center line of the carriageway (on existing road) which is not in conformity with Ministry's guidelines vide letter no. NHIII/ P/ 66/76 dated 19.11.1976. However, in the bypass/realigned portion, the proposed laying of water supply pipeline is at a distance of 29.5 m which is in conformity with Ministry's guidelines vide letter no. NHIII/ P/ 66/76 dated 19.11.1976. Further, the Commissioner, Madurai Corporation has given undertaking that the lay of water pipe line is proposed to lay by **Open Trench Method** for a distance of 14.5 m from the center line of the carriageway (on existing road) & 29.5 m on bypass/realigned portion and Across at Km 246/300, Km 250/600 & Km 80/435 by **HDD Method** at a depth of 2 m from the bottom of the ground.

4. The Commissioner, Madurai Corporation has furnished an undertaking to the effect that they will remove the laid of water pipeline in future if required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of water supply pipe line work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the relaxation application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
