Invitation of public comments

Sub: NHAI, Madurai Region - PIU, Dindigul - Permission for laying water supply pipeline along NH from Km 346/100 to Km 347/300 (LHS) in Karur - Dindigul section of NH -7 in the State of Tamil Nadu - Proposal submitted - Reg

The proposal is regarding permission for laying water supply pipeline along NH from 346/100 to Km 347/300 (LHS) in Karur - Dindigul section of NH -7 in the State of Tamil Nadu was submitted to this office by PD, PIU Dindigul vide letter No. NHAI/PIU/DGL/11014/02/Water Pipe Line/2019/1413 dt. 21.11.2019 (received on 26.11.2019) in accordance with Ministry's latest guidelines dated 22.11.2016.

2. The alignment proposed by the Executive Engineer, TWAD Board, RWS Division, Dindigul, for laying water supply pipeline along NH from Km 346/100 to Km 347/300 (LHS) in Karur - Dindigul section of NH -7 in the State of Tamil Nadu i.e. in a length of 1200 m as detailed under:

Stretch in Km	Length (m)	ROW (m)	Dist. Of Prop. pipeline from Centre of NH (m)
Along the road: size of pipe - 63mm dia PVC Pipe			
Along the road : Km 346/100 to Km 347/300 (LHS) on NH-7	1200	60	29.50

3. The right of way is 60m in the aforesaid stretch. The Executive Engineer, TWAD Board, RWS Division, Dindigul has proposed to lay water pipe line at the extreme edge of the ROW for a length of 1200 m. The laying of water supply pipe line is proposed to be laid at a distance more than 29.5 m from the center line of the carriageway which is in conformity with Ministry's guidelines vide letter no. NHIII/ P/ 66/76 dated 19.11.1976. Further, the Executive Engineer, TWAD Board, RWS Division, Dindigul has given undertaking that the lay of water pipe line is proposed to lay by **Open Trench Method** for a distance of 29.5 m from the center line of the carriageway at a depth of 2m from the bottom of the ground.

4. The Executive Engineer, TWAD Board, RWS Division, Dindigul has furnished an undertaking to the effect that they will remove the laid of water pipeline in future if required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of water supply pipe line work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the relaxation application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
