The proposal is regarding permission for laying of of 8"/12" Carbon Steel Gas Pipeline from NH Design Ch. Km. 0.00 (Near Haryana Hotel, NH Old Ch. Km. 364.125 of NH-8) to NH Design Ch. Km. 92.250 (Near Jodhpur Misthan Bhandar, Barmer on Ajmer-Udaipur road, Chungi Naka, NH Old Ch. 

Please refer this office letter dated 27.08.2021 (Annex-1), vide which the proposal of M/s. Indraprastha Gas Ltd. for laying of 8"/12" Carbon Steel Gas Pipeline from NH Designed Ch. Km-0.00 (Near Haryana Hotel, NH Old Ch. Km-364.125 of NH-8) to NH Designed Ch. Km 92.250 (Near Jodhpur Mishthan Bhandar, Beawar on Ajmer-Udaipur Road, Chungi Naka, NH Old Ch. Km-58.125 of NH-58) along the National Highway No.-08 (New NH-48) & Crossing of NH at various locations in the State of Rajasthan was submitted to RO, NHAI-Jaipur with the recommendation of this office for issuance of "In-Principle" approval of Competent Authority.

Competent Authority NHAI, RO-Jaipur vide their letter dated 28.09.2021 (Annex-2) has conveyed certain observations. This office vide letter dated 07.10.2021 (Annex-3) has asked to IE for their comments/recommendations w.r.t. the observations mentioned at point no. (iv) of RO-Jaipur letter. Similarly, the observations mentioned at point no. (i) & (ii) were communicated to M/s. Indraprastha Gas Ltd. for necessary compliance vide this office letter dated 08.10.2021 (Annex-4).

In this regard, IE as well as Indraprastha Gas Ltd. has submitted compliance vide its letters dated 14.10.2021 & 13.12.2021 (Annex-5 & 6) respectively. Accordingly, the point wise clarification are as under:-

(iii)	Calculation sheet of required amount of License Fees and B.G. enclosed with the proposal has not been signed by PD.	Calculation sheet of required amount of License Fees and B.G. duly signed by PD is enclosed as Annex-7.
(iv)	PD has recommended for grant of NOC for all the locations proposed by the applicant, whereas IE in his letter no. 1954 dated 15.04.2021 has denied to grant permissions at the locations of existing structures and 4 nos. ROBs. The structural safety and methodology for laying/ crossing of Gas Pipeline is also required to be reviewed at these locations.	It is submitted that IE vide its letter dated 15.04.2021 has pointed out certain observations which was communicated to agency vide this office letter no. 11181 dated 20.04.2021 for necessary revision of the proposal. • In response to above, agency vide its letter no. 2307-1 dated 22.07.2021 (Annex-8) submitted that the crossing of NH at Ch. 5.780 is unavoidable because there is no alternate option to distribute CNG to Roopangarh area, however, agency has assured that they will not damage any structure of NH and committed to maintain the depth of 4 to 5 mtr at this location. Further, the agency has shifted crossing of NH at Ch. 38.120 to Ch. 38.330 and again assured that they will not damage any structure of NH and committed to maintain the depth of 4 to 5 mtr at this location. • As regards to the ROBs, agency vide its letter no. 1608 dated 16.08.2021 (Annex-9) has submitted that they will take separate permission from competent authority of Railway to cross the Railway tracks before laying the Gas Pipeline. • For structural safety and methodology for laying/crossing of Gas Pipeline, agency in its above mentioned letter dated 16.08.2021 has submitted that "the attached methodology is authentic and related to Gas Pipeline and it's based on PNGRB (Petroleum and Natural Gas Regularoty Board) Guidelines.
		Based on the facts stated above, IE vide its letter dated 14.10.2021 (Annex-5) has submitted its comments that "Authority may consider the same." Accordingly, the proposal was recommended.

In view of the above clarifications, the proposal is again submitted with the recommendation of this office to accord the "In-principle" approval of Competent Authority to M/s. Indraprastha Gas Ltd. for subjected work.
