## **Invitation of Public Comments**

Sub: Proposal for grant of NOC for laying / crossing of 33 KV overhead line across NH-361 at Km.14.815 from Tuljapur City in Internal Lane from Lohara PSS of M/s. Siemens Gamesa Renewable Private Limited Cehnnai Line from wind farm – Reg.

Ref.: (i) PD, PIU, Nanded Lr.No.NHAI/PIU/NED/NH361/NOC-SIEMENS/DLBL TAHL/LION/2019/31, dtd.04.01.2020 (ii) M/s. Siemens Games Renewable Energy Lr.No.SG/MH/PD/108/2019-20, dated 01.10.2019

It is to inform all concern that the M/s. Siemens Gamesa Renewable Energy, Chennai vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Nanded has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that the M/s. Siemens Gamesa Renewable Energy, Chennai across Tuljapur- Ausa Section of NH-361 in the State of Maharashtra is as follows:
  - Crossing 33 KV Overhead line is at Km.14.815 from Tuljapur City
  - The Tower on LHS and RHS are located at a distance of 45m and 41m respectively from PCL of Highway.
  - The locations of Tower comes out of Building line i.e. 40m on each side.
  - The Tower Height 12.96m, proposed to be installed beyond ROW.
  - The vertical clearance from RTL is 11.60m
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to crossing of 33KV Overhead line on the subjected stretch. The objections / comments may be addressed to the below mentioned address upto 26.02.2020, beyond due date, no comments/ objections will be accepted.
