Sub: Proposal of permission for laying / Crossing of 11 KV underground cable at Km.37.500 near Bazargaon on Nagpur – Kondhali Section of NH-53 in the State of Maharashtra by MSEDCL, O&M Division, Katol- Reg.

It is to inform all concern that the Executive Engineer, Maharashtra State Electricity Distribution Co. Limited, Nagpur vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Nagpur has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that the Executive Engineer, Maharashtra State Electricity Distribution Co. Limited, Nagpur is as follows:

- Crossing at Km.37.500
- Laying of above utility is in utility corridor between 29 m-30m from the centre line
- Crossing will be through HDD Method only encased in 11 KV GI Pipe

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).


