## Notice inviting public comments in respect of Extension of Time for 'in-principle' NOC

Sub: Proposal for grant of access permission to the proposed retail outlet by M/s.BPCL at km.66/528-655 (LHS, survey no. 65/A, 65/E/AA) of Hyderabad-Bangalore Section of NH-44 at Rangareddvguda Village, Balanagar Mandal, Mahabubnagar District in the State of Telangana-Reg.

This has reference to the letter vide reference 1st cited above, wherein the Proposal for grant of access permission to the proposed retail outlet by M/s.BPCL at km.66/528-655 (LHS, survey no. 65/A, 65/E/AA) of Hyderabad-Bangalore Section of NH-44 at Rangareddyguda Village, Balanagar Mandal, Mahabubnagar District in the State of Telangana was sent to MoRT&H, RO Hyderabad.

- As per Gazette Notification S.O.No.3292 (E) dated 16.09.2019, MoRT&H Regional Officer, Hyderabad had transferred the subject proposal to NHAI, RO Hyderabad in the letter vide reference 4th cited.
- MoRTH, New Delhi vide Ir.no.NH-12017/11/2009/AP/NH-7 dt 8.4.2009 communicated the access 3. permission approval of M/s BPCL at Km 66/232-407 (LHS) of NH-7 as per Ministry circular no. No. 11041/21/2002-Admin dated 04.11.2003. However, as the Construction is not completed by the Retail Outlet within 1 year, Ministry vide Ir.no.RW/HYD/Misc-24/Access/NHAI/988 dated 17.12.2014, has informed that the provisional NOC for access permission of M/s. BPCL is deemed to be cancelled and stands withdrawn.
- However, As per The Hon'ble Sri Justice S.V. Bhatt, Writ Petition No: 20824 of 2016, pronounced on 21.12.2017, M/s BPCL has submitted a fresh proposal to this office and requested for grant of Access Permission for BPCL Retail Outlet at Sy Nos. 65/A, 65/E/AA Rangareddyguda Village, Balanagar Mandal, Mahabubnagar District in the State of Telangana on NH-44 at Km.66/528-655 on LHS of Hyderabad-Bangalore Section of NH-44.
- Therefore, the subject proposal is put in public domain, inviting comments from public on the above-mentioned proposal due to non-fulfillment of criteria of Construction within a year of issuing NOC as per Ministry vide OM No.RW/NH/33023/19/99-DO.III dated 16.03.2016 and as per Judgement of The Hon'ble Sri Justice S.V. Bhatt, Writ Petition No: 20824 of 2016.
- In view of the above, the comments from public on the above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in) as per Form-A (copy enclosed).

Please find enclosed herewith the proposal of M/s BPCL Retail Outlet at Sy Nos.65/A, 65/E/AA Rangareddyguda Village, Balanagar Mandal, Mahabubnagar District in the State of Telangana on NH-44 at Km.66/528-655 on LHS submitted for approval of NH Authority.

### Background

- (i) Earlier, M/s BPCL had submitted a proposal on 04.02.2008 for grant of No Objection Certificate and access permission for approach road to new Fuel Station at Rangareddyguda Village, Balanagar Mandal, Mahaboobnagar District abutting NH7 @ Km.66/232-407 (LHS) of Hyderabad-Bangalore Section of NH-44.
- (ii) MoRTH, New Delhi lr.no.RW/NH-12017/11/2009/AP/NH-7 dated 08.04.2009 had given the approval for the Fuel Station at Rangareddyguda Village, Balanagar Mandal, Mahaboobnagar District abutting NH7 @ Km.66/232-407 (LHS) of Hyderabad-Bangalore Section of NH-44.
- (iii) The Regional Officer, MoRTH, Hyderabad vide lr.no.RW/HYD/Misc-24/Access/NHAI/988 dated 17.12.2014 had declared the proposal as deemed to be cancelled duly stating that the completion certificate as stipulated in provisional NOC had not been received within one year from the date of approval.

- (iv) Upon the cancellation of provisional NOC by MoRTH, M/s BPCL including adjacent Private Property owner Marunganti Lakshma Reddy & Marunganti Premlata Devi have approached Hon'ble High Court and prayed for suspension of MoRTH Provisional NOC cancellation vide W.P.No.20824 of 2016. On the above W.P, Interim stay order dated 27.06.2016 was pronounced by the Hon'ble High Court on cancellation of provisional NOC by MoRTH.
- (v) Based on the Interim Stay order dated 27.06.2016 given by Hon'ble High Court, PIU-Hyderabad vide Ir.no. NHAI/PIU-HYD/AP-3/Km.66.232/BPCL/ 2016/1434 dated 29.06.2016, had directed the concessioner not to proceed to cut the access as per the order given vide letter dated 03.06.2016 untill further directions from the Hon'ble High Court.
- (vi) The final W.P.No.20824 of 2016 was pronounced on 21.12.2017 (copy enclosed), wherein Hon'ble High Court vide W.P.No.20824 of 2016 has given order that "seeking to remove the connectivity to National Highway No.44 of the Petitioners Food Court in Survey No.65 admeasuring 2 acres situated in Rangareddyguda Village, Balanagar Mandal, Mahabubnagar District as arbitrary illegal and set aside the same" and W.P.No.20573 of 2016 has given order that "direction declaring the action of the respondents in taking steps to cut the access to the retail outlet situated at Km 66/232-407 of Hyderabad-Bangalore Section of NH-44 to the National Highway as illegal arbitrary and is in violation of principles of natural justice and pass such other or further orders as the Court feels deem fit and proper in the facts and circumstances of the case".
- (a) The interim order granted on 27.06.2016 is directed to be continued for a period of four (04) months from 21.12.2017.
- (h) The petitioners can inform respondent Nos.1 to 3, the present state of affairs including the developments undertaken by the petitioners.
- (c) The 2<sup>nd</sup> respondent causes physical inspection on the representation of petitioners, forwards a report to 1<sup>st</sup> respondent for taking a decision within the time granted by this Court.
- (vii) As per court orders, PIU -Hyderabad, vide letter no. NHAI/PIU-HYD/AP-3/Km 66.232/BPCL/2016/866 dated 27.09.2018, has very recently sought the status from M/s BPCL & M/s Marunganti Lakshma Reddy & Marunganti Premlata Devi with regards to the action taken report on the development to be undertaken by the Petitioners as per Court orders. Since, the reply had not been received on time, PIU-Hyderabad vide letter NHAI/PIU-HYD/AP-3/Km 66.232/BPCL/2016/978 dated 15.10.2018, had again initiated and instructed the concessioner to cut the access to the said permission immediately.
- (viii) On this move, they have again went to Hon'ble High Court, Hyderabad. Hon'ble High Court of Telangana & AP granted interim stay on 26.12.2018 in IA No.1 of 2018 in W.P.No.47041 of 2018 (copy enclosed) for the letter under ref. lr.NHAI/PIU-HYD/AP-3/Km.66.232/BPCL/2016/1198 dated 12.12.2018, that no coercive action pursuant to the impugned order dated 12.12.2018 shall be taken till further orders. As such the Court yet to issue further orders and the matter is under subjudice.

- Now, M/s BPCL vide ref. 1st cited has come forward for laying of service road for both the parties and requesting this office for grant of No Objection Certificate for BPCL Retail Outlet at Sy Nos.65/A, 65/E/AA Rangareddyguda Village, Balanagar Mandal, Mahabubnagar District in the State of Telangana on NH-44 at Km.66/528-655 on LHS of Hyderabad-Bangalore Section of NH-44. The proposal has been examined and is satisfying the norms given in MORTH Circular No.RW/NH-33023/19/99-DO-III dated 24.07.2013. Vide ref. 1st cited, M/s BPCL have submitted the proposal 2 sets (2 Original) each with the following documents is enclosed herewith along with a Transaction Ref.No. 2101190002482 transfer to Bharatkosh.gov.in dated 21.01.2019 for Rs.10,000/- towards processing fee in favour of Regional pay & Accounts Officer, NH, MORTH.

  - 2. Undertakings for approach roads.

4. Rain Water Design calculations for culvert.

5. Affidavit issued by land owner

- 9. Certified copy of Layout plan of the retail outlet showing Deceleration and Acceleration lanes.
- 10. Certified copy of 1.5 KM Radius Location Plan (Key Plan).

13. It is certified that

"the License Agreement submitted by the applicant has been compared verbatim with latest Ministry's format given in MORTH Circular No. RW/NH-33023/19/99-DO-III dated 24.07.2013 and is found correct".

- 4. IE vide lr. no.2261 dated 16.02.2019 informed that M/s BPCL complies with the check list of the Ministry Circular guidelines and NOC may be granted insisting forming/ execution of the same suitably as per MoRTH Circular No.RW/NH-33023/19/99-DO-III dated 24.07.2013.
- 5. In view of the above, it is requested to issue the NOC & Permission for access to Retail Outlet of M/s BPCL for the above location abutting Hyderabad-Bangalore Section of NH-44 may be accorded please by construction of service road of length 387.0m from Km.66/368 to Km.66/755.
- 6. Further, NHAI, Vigilance Department is also pressing hard on the regularization of illegal access to this Retail Outlet and compliance yet to be furnished as the matter is under subjudice. The proposal may be considered under relaxation as the provisional NOC was already issued by Ministry for construction of Acceleration / Deceleration lanes to this Retail Outlet.


