It is to inform all concern that the Executive Engineer, Maharashtra Jeevan Pradhikaran, Nagpur vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Amravati has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that the Executive Engineer, Maharashtra Jeevan Pradhikaran, Nagpur is as follows:

- Laying of Water supply lines along NH-53 from Km.9.400 to Km.10.520 on RHS at village Wadi, Tq & Dist. Nagpur.
- 90mm Water supply pipe lines through manual excavation proposed.
- Laying of above utility is in utility corridor

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).


