

Amravati, Dist. Amravati.

It is to inform all concern that M/s Maharashtra Industrial Development Corporation vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Amravati has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that M/s Maharashtra Industrial Development Corporation along on Nandgaon Peth to Amravati Industrial Area section on New NH-53 (old NH-6) in the State of Maharashtra is as follows:
 - Underground Water supply pipe line for MIDC Amravati on Crossing National Highway NH-53 (old NH-6) at Km. 141.100,152.600,155.870 & 157.800 & along (Parallel) NH-53 From Km. 140.200 to 156.678 for water supply connection from Nandgaon peth to Amravati Industrial area.
 - Alignment of the water supply pipeline is along Nadgaon peth to MIDC Amravati on NH-53.
 - Casing pipe to be laid in Duct 1.5m below ground level.
 - Water supply pipeline to be laid by HDD method
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
