
1. M/s My Own Eco Energy Pvt. Ltd. i.e the applicant vide letter dated 10.01.2018 has submitted a proposal to this office on the above mentioned subject. The applicant is requesting relaxation from Ministry's guideline issued vide letter no. RW/NH-33023/19/99-DO.III dated 24.07.2013 as due to a "intersection with any category of roads (irrespective of carriageway width)" is 10m as against the norm of 100m and "Gap in the central median from fuel station (for divided carriageway only)" is 102m as against the norm of 300m.
2. As per Ministry's vide OM No. RW/NH/33023/19/99/DO-III dated 16.03.2016, the highway administrator will make available the relaxation proposal along with Form-A in the ministry's website (morth.nic.in) for public comments for a period of 60 days.
3. In view of the above, comments of the public if any on the above relaxation proposal are invited on online as well as in hard copy. The same should reach to the below mentioned address within 60 days from the date of uploading in the website, beyond which no objection will be considered.

consideration and necessary action.

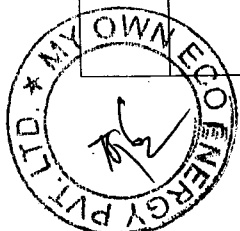
