

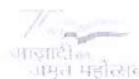

Invitation of Public Comments

Sub: Proposal for grant of permission for laying of underground 300mm NB dia. Carbon Steel & 90mm MDPE Natural Gas Pipeline along and across the NH-37 from Ch. Km 6.25 to Ch. Km 10.66 and Crossing at Ch. 8.757 (Length= 4333m) - Reg.

The GM (P), PMU-Silchar vide letter PMU-Silchar/U/OFC/2023-24/2792 dated 13.04.2023 has submitted a proposal along with recommendation for according ROW Permission for laying of 300 mm NB dia. Carbon Steel & 90 mm MDPE Natural Gas Pipeline from Chainage 6.25 km to Km 10.66 including crossing at Km 8.757 through Horizontal Directional Drilling Method across NH-37. The applicant, Purba Bharati Gas Pvt. Ltd. had submitted their proposal to the PMU vide their letter no PBG/GA9.02/NHIDCL-ROU/NH37/01, PBGPL/GA9.02/NHIDCL-ROU/NH37/02 and 04 dated 01.11.2022, 22.12.2022 and 20.03.2023 respectively. The GM(P), PMU-Silchar has certified the proposals, checklist and drawings as per the extant practice.

2. The subject cited NH Section is presently under DPR Stage and is being developed to a 4 Lane facility.

3. As per Ministry's circular no.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequent modifications dated 17.04.2023 and 24.04.2023, the Highway administrator will make available the subject proposal on the portal for 30 days seeking for public comments on ground of public interest.

4. In view of the above, the comments of the public are invited on the captioned proposal and the same should reach the below mentioned address till 30 (thirty) days from the date of public interest.
