Invitation of public comments

Subject:- Permission proposal for laying underground water supply pipe along the road from Km 54/700 to 56/000(LHS), Km 58/600 to 63/000(RHS), Km 63/600 to 65/200(LHS), Km 70/600 to 72/400 (RHS), Km 74/050 to 74/400(RHS) and crossing the road at Km 34/400, Km 50/100, Km 55/400, Km 56/000, Km 59/900, Km 61/200, Km 65/200, Km 65/500, Km 70/600, Km 74/050, Km 74/400 of NH-230 (Madurai -Thondi Road) in the state of Tamil Nadu- Reg.

The proposal is regarding request for permission for laying underground water supply pipe along the road from Km 54/700 to 56/000(LHS), Km 58/600 to 63/000(RHS), Km 63/600 to 65/200(LHS), Km 70/600 to 72/400 (RHS), Km 74/050 to 74/400(RHS) and crossing the road at Km 34/400, Km 50/100, Km 55/400, Km 56/000, Km 59/900, Km 61/200, Km 65/200, Km 65/500, Km 70/600, Km 74/050, Km 74/400 of NH-230 (Madurai -Thondi Road) in the state of Tamil Nadu by the Executive Engineer, TWAD Board, Project Division, Sivagangai resubmitted to this office by the SE (NH), Madurai vide letter No. 2556/2022/DO dated 03.07.2023(received on 10.07.2023). The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying water pipe line is varying from 13.00m to 31.00m. The carriageway width of stretch from Km 54/700 to 56/000(LHS), Km 58/600 to 63/000(RHS), Km 63/600 to 65/200(LHS), Km 70/600 to 72/400 (RHS), Km 74/050 to 74/400(RHS) of NH-230 is 10.00m to 16.00. The Executive Engineer, TWAD Board, Project Division, Sivagangai has proposed to lay the underground water pipeline at edge of the ROW for a length of 9450m by adopting open trench method along the National Highway and HDD method across at Km 34/400, Km 50/100, Km 55/400, Km 56/000, Km 59/900, Km 61/200, Km 65/200, Km 65/500, Km 70/600, Km 74/050, Km 74/400 the National Highway.


3. The Executive Engineer, TWAD Board, Project Division, Sivagangai has furnished an undertaking to the effect that they will remove the laid Public Utility water pipeline in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, TWAD Board, Project Division, Sivagangai will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
