2. The Right of Way in the stretch of NH proposed for laying Water pipe line is from 19.10m to 41.30m. The carriageway width of stretch from Km 75/700 to Km 83/765,Km 84/980 to Km 110/680,Km 83/605 to Km 83/765 (RHS)of NH 532 is 16.50m to 28.00m. the ROW for a length of 33925m by adopting open trench method along the National Highway and HDD method crosses at Km 75/700,Km 83/765,Km 84/980the National Highway.

The Executive Engineer, TWAD Board, RWS Division, Salem has furnished an undertaking to the effect that they will remove the laid Public Utility water pipe line in future if required by NH Authorities/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH Authorities/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, TWAD Board, RWS Division, Salemwill also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
