Proposal seeking ROW permission for laying of 600mm Diameter Pipeline and 900mm Diameter Casing Pipe, 1200mm Diameter Pipeline Trench Drinking Water Pipeline along NH-48 from Km 370+920 to Km 377+400 on LHS and crossing at Km 377+400, near Village-Valvada to Bhilad, Taluka-Umargaon, District-Valsad in the state of Gujarat.
