- SUB: Up-gradation to Four-lane Divided Carriageway with Paved Shoulder from Patan (near khan Sarovar Lake) to Gojariya Km 52+000 to Km 128+940 (Length 79+175 Kms) of NH-68 in the state of Gujarat.
 - Proposal seeking ROW permission for laying of 8" Steel Dia Gas Pipeline Connectivity for Param Patan upto M/s. RM Petroleum CNG Station & M/s. Jayveer CNG Station, Taluka-Chanasma. District-Patan (i) Parallel to NH-68 Patan (Rajpur)-Gozariya Road (RHS) from Km 52+000 to Km 62+800, (ii) Parallel to NH-68 Patan (Rajpur)-Gozariya Road (LHS) from Km 62+800 to Km 63+740 and (iii) Crossing of NH-68 Patan (Rajpur)-Chanasma Road at Km 62+800 in the state of Gujarat.
