Sub: 4-laning of Madhya Pradesh/Maharashtra Border Nagpur Section of NH-7 from Km.652.000 (New Km.653.225) to Km.729.000 including construction of Kamptee - Kanhan and Nagpur Bypass and Maintenance of already 4 -laned sections from Km.14.585.000 to Km.36.600 NH-7 (Nagpur-Hyderabad Section) in the State or Maharashtra under NHDP Phase-II on DBFOT Basis- **Proposal for permission for laying of 33 KV 300 sqmm UG cable along the National Highway from km 23.100 to km 24.900 (total length 1.8km) on NH-44 (Nagpur-Chandrapur Highway) from Butibori to Satgaon Fata Butibori under Tender T-02 (OH-UG) Scheme under Butibori divisional - Approval-Reg.**

2. The alignment proposed by that M/s MSEDCL for subject section of NH-44 in the State of Maharashtra is as follows:

- Laying of 11KV underground line from km 23.100 to km 24.900 total km 1.800.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
