It is to inform all concern that M/s MSEDCL vide letter under reference (2) has submitted a proposal for the subjected work and PD, PIU Aurangabad has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s MSEDCL is across the section of Yedshi - Aurangabad on NH-52 is as follows:

- 10 nos. of crossings at km 282.300, km 285.000, km 282.800, km 271.200, km 269.600, km 273.850, km 264.900, km 263.850, km 265.350 & km 265.000 (Through HDD).

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
