Invitation of Public Comments

Sub: National Highway Crossing Proposals of 400 KV D/C (Twin) Nangalbibra-Bongaigaon Transmission line to cross over NH-17 (Old- 31B & 37) Seeking approval of 5 (five) crossings - **Reg.**

The GM (P), PMU-Bongaigaon vide letter PMU-BNGN/B-G/Pkg-5/EL/22-23/3534 dated 20.07.2023 has submitted a proposal along with recommendation for according 05 crossings permission along NH-17 (Old- 31B & 37) for 400 KV D/C (Twin) transmission line viz. AP 64/0 to AP 65/0 at chainage Km 0+400, AP 65/0 to AP 66/0 at chainage Km 19+400, AP 73/0 to AP 74/0 at chainage Km 14+905, AP 78/0 to AP 79/0 at chainage Km 17+770 & AP 86/0 to AP 87/0 at chainage Km 21+560. The applicant, Nangalbibra- Bongaigaon Transmission Limited had submitted their proposal to the PMU vide their letter: NBBG-SPGL-NHIDCL-LT-230 dated 14.12.2022. The GM(P), PMU-Bongaigaon has certified the proposals, checklist and drawings as per the extant practice.

2. The subject cited NH Section is presently under construction and is being developed to a 4 Lane facility.

3. As per Ministry's circular no.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequent modification dated 15.01.2021, the Highway administrator will make available the subject proposal on the portal for 30 days seeking for public comments on ground of public interest.

4. In view of the above, the comments of the public are invited on the captioned proposal and the same should reach the below mentioned address till 30 (thirty) days from the date of public interest.
