Sub: NHAI - PIU - Puducherry - N/08019/01002/TN - Four laning of Villupuram (Km.0/000) to Puducherry (Km.29/000) Section of NH-45A (New NH-332) on HAM under Bharatmala Pariyojana in the state of Tamil Nadu and UT Puducherry under NHDP Phase - Proposal seeking NOC & Permission for laying of Sewerage Pumping main pipeline crossing at Km.3/950 of NH-45A Viluppuram to Nagapattinam section in Viluppuram District - Invitation of Public Comments - Reg.

- 1. The subject proposal is requesting permission for laying of underground Sewerage Pipeline across the road at Km.3/950 of 150mm dia CI Pipe by HDD Method at the depth of 1.2m in the project stretch of Viluppuram to Puducherry Section of NH-45A (New NH-332) in the State of Tamil Nadu and UT Puducherry under NHDP Phase by the Executive Engineer, TWAD Board, RWS Division, Viluppuram in accordance with Ministry's latest guidelines Dt.22.11.2016.
- 2. The Executive Engineer, TWAD Board, RWS Division, Viluppuram has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, TWAD Board, RWS Division, Viluppuram will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
