- SUB: Six Laning of Ahmedabad to Vadodara section of NH-8 from Km. 6.400 to Km. 108.700 (Length 102.300 Km) and Improvement of Ahmedabad-Vadodara Expressway from Km. 0.000 to Km. 93.302 in the State of Gujarat (Length 93.302 Km) under NHDP Phase V on Design, Build, Finance, Operate & transfer (DBFOT) Toll Basis.
  - Proposal seeking ROW Permission for laying 300mm Dia Drainage Pipeline along NH-48 from Km 9+000 to Km 9+120 (Total Length 120m) on Ahmedabad-Vadodara section of NH-48 in the state of Gujarat.
