Invitation of Public Comments

Sub: Permission for laying of proposed 12 inch steel Gurdaspur-Jammu Gas Pipeline alongwith OFC cable along & across NH-44/NE-5 (Delhi-Amritsar-Katra Expressway) in District Kathua & Samba in Jammu & Kashmir (34817.72 m in length)

The proposal regarding issuance of NOC for laying of proposed 12 inch steel Gurdaspur-Jammu Gas Pipeline alongwith OFC cable along & across NH-44/NE-5 (Delhi-Amritsar-Katra Expressway) in District Kathua & Samba in Jammu & Kashmir (34817.72 m in length) has been submitted to this office by PD, PIU Jammu letter No. PD/JMU/DKE/Pkg-15/2024-25/1995 dated 22.07.2024 in accordance with Ministry guidelines dated 22.11.2016 and circular dated 17.04.2023.

2. The submitted proposal is in conformity with Ministry's latest guidelines dated 22.11.2016 and 17.04.2023 regarding accommodation of public and industrial utility services along and across National Highways.

3. M/s GAIL India Ltd has furnished an Undertaking to the effect that they will shift the utility if required at any time owing to expansion of the road or if necessary by the NH Authority at his own cost and risk without claiming any cost from NHAI. Further, they have furnished an undertaking that not to damage other utility, if damaged then to pay the losses either to NHAI or to the concerned agency. The applicant has undertaken to indemnify against all damages and claims by NHAI. Also, certified that the proposed laying of utility will not have any deleterious effect on any of the bridge components and road way safety for traffic.

4. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s GAIL India Ltd will be made available for public comments/objections within 30 days from the date of uploading of this notice.
