Invitation of public comments

**Subject:-** Permission proposal for laying of sewer pipe line along the road from Km 04/050 to Km 04/150 (LHS), Km 04/000 to Km 04/800(RHS) and across at Km 04/150 of NH-210(New NH-336)(Trichy-Pudukottai road) in Tiruchirapalli district in the state of Tamil Nadu by the Commissioner, Tiruchirapalli City Corporation, Tiruchirapalli -Reg.

The proposal is regarding requesting permission for laying of sewer pipe line along the road from Km 04/050 to Km 04/150 (LHS), Km 04/400 to Km 04/800(RHS) and across at Km 04/150 of NH-210(New NH-336)(Trichy-Pudukottai road) in Tiruchirapalli district in the state of Tamil Nadu by the Commissioner, Tiruchirapalli City Corporation, Tiruchirapalli submitted to this office by the SE (NH), Madurai vide letter No. 199/2024/JDO-2/NH dated 18.03.2025. The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying sewer pipe line is from 34.50m to 37.50m. The carriageway width of stretches from Km 04/050 to Km 04/150, Km 04/000 to Km 04/800 of NH-210(New NH-336) is 20.00m. The Commissioner, Tiruchirapalli City Corporation, Tiruchirapalli has proposed to lay the underground Public Utility at edge of the ROW for a length of 950m by adopting open trench method along the National Highway and HDD method crosses the National Highway at Km 04/150.

3. The Commissioner, Tiruchirapalli City Corporation, Tiruchirapalli has furnished an undertaking to the effect that they will remove the laid Public Utility water pipe line in future if required by NH Authority/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH Authority/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Commissioner, Tiruchirapalli City Corporation, Tiruchirapalli will also restore the ROW surfaces to its original condition soon

after removal of the Public utility sewer pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
