Invitation of Public Comments

Sub: Proposal for grant of permission for the work of laying of 11KV UG (Underground) Cable under Capex budget at Patnitop Tourist spot on NH-244.

The proposal regarding issuance of NOC for permission for laying of 11KV UG (Underground) Cable under Capex budget at Patnitop Tourist spot on NH-244 (1.93 Km length) in the UT of Jammu & Kashmir has been submitted to this office by PD, PIU Udhampur letter No. 24030/3/2022/PIU-Udp/NOC/1382 dated 31.10.2025 in accordance with Ministry guidelines dated 22.11.2016 and circular dated 17.04.2023.

2. The submitted proposal is in conformity with Ministry's latest guidelines dated 22.11.2016 and 17.04.2023 regarding accommodation of public and industrial utility services along and across National Highways.

3. JPDCL has furnished an Undertaking to the effect that they will shift the utility if required at any time owing to expansion of the road or if necessary, by the NH Authority at his own cost and risk without claiming any cost from NHAI. Further, they have furnished an undertaking that not to damage other utility, if damaged then to pay the losses either to NHAI or to the concerned agency. The applicant has undertaken to indemnify against all damages and claims by NHAI and also submitted other requisite undertakings.

4. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by JPDCL will be made available for public comments/objections within 30 days from the date of uploading of this notice.
