Sub: NHAI, PIU-Viluppuram - Four laning of Km. 0/313 to Km. 136/670 of Salem to Ulundurpet section on NH-79(Old NH-68) in the State of Tamil Nadu (Package No. NHDP-III/BOT-I/TN-06) - Requesting permission for laying underground Sewerage Pipeline along the road from Km. 0/377 to Km.0/489 (LHS) for a length of 112 meters at the road of Salem to Ulundurpet section of NH-79 - Approval requested-reg.

1. The subject proposal is requesting permission to lay underground Sewerage Pipeline along the road from Km. 0/377 to Km.0/489 (LHS) for a length of 112 meters in the project stretch of Salem to Ulundurpet Section of NH-79 (Old NH-68) in the State of Tamil Nadu.
2. The Commissioner, Salem City Municipal Corporation, Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Commissioner, Salem City Municipal Corporation, Salem will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
