Invitation of public comments

Subject:- Permission proposal for laying underground water supply pipe along the road from Km 67/365 to Km 119/710 of NH-32(Old NH-176) Thoothukudi-Tiruchendur-Kanyakumari road in the state of Tamil Nadu- for providing CWSS to 381 Rural Habitations in Tirunelveli district-TWAD pipe line laying- Reg.

The proposal is regarding request for permission for laying underground water supply pipe along the road from Km 67/635 to Km 119/710 of NH-32(Old NH-176) Thoothukudi-Tiruchendur-Kanyakumari road in the state of Tamil Nadu by the Executive Engineer, TWAD Board, Urban Division, Tirunelveli resubmitted to this office by the SE (NH), Tirunelveli vide letter No.2114/2023/JDO dated 18.11.2023(received on 20.11.2023). The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying Water pipe line is 8.30m to 15.30m. The carriageway width of stretch from Km 67/365 to Km 119/710 of NH-32(Old NH-176) is 7.30m. The Executive Engineer, TWAD Board, Urban Division, Tirunelveli has proposed to lay the underground Public Utility at edge of the ROW for a length of 30575m by adopting open trench method along the National Highway and by HDD method crosses at Km 67/635, Km 78/940, Km 79/300 Km 109/530, Km 110/470, Km 111/400, Km 113/500, Km 114/010, Km 114/940, Km 115/540, Km 116/830, Km 118/360, Km 119/170 & m 119/520 of the National Highway.

3. The Executive Engineer, TWAD Board, Urban Division, Tirunelveli has furnished an undertaking to the effect that they will remove the laid Public Utility water pipe line in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, TWAD Board, Urban Division, Tirunelveli will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
