This has reference to the letter mentioned above vide which Project Manager, (Works & Planning) JUIDCO, Ltd has re-submitted proposal for Issuance of NOC for proposed laying of water supply pipelines for Ranchi water Supply Scheme Phase-2, Package-A for approval on above cited project.
