Invitation of Public Comments

SUB: Four laning with Paved Shoulder Porbandar-Dwarka section of NH8E (Extn.) from Km 356.766 (Design chainage Km 379.100) to Km 473.000(Design chainage Km 496.848) in the State of Gujarat through Public Private Partnership (PPP) on Hybrid Annuity Mode.

- Proposal seeking ROW permission for laying proposed underground Drainage Water Pipeline along and across NH-51 for providing basis utility service along (Total 284 Km Along) NH-51 from Km 496+070 to Km 496+294 300mm Dia RCC pipe (224m Along), Km 496+385 to Km 496+445 (60m Along) 150mm Dia RCC pipe and crossing at Km 496+070 400mm Dia DWC pipe carrying (800mm Dia MS casing), Km 496+445 150mm Dia RCC (500mm Dia MS casing) at Village-Dwarka, Taluka-Dwarka, District-Devbhoomi Dwarka in the state of Gujarat.
