Sub: Four laning of Amravati- Chikhali section of NH-6 Package-I (km 160.000 to km 220.000) -Proposal for laying of Pipeline from (1) km 226.100 to km 229.100 (2) km 261.950 to km 262.100 and crossing at (1) km 226.160, (2) 254.800 (3) 261.950, (4) 267.450 on Amravati Chikhali section of NH-53- Reg.

It is to inform all concern that Executive Engineer, MJP, Akola Division vide letter under reference (ii) has submitted a proposal for the subjected work and PD, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that MJP, Akola along on Amravati to Kurankhed Section of NH-53 (Old NH-06) in the State of Maharashtra is as follows:

- Laying of pipeline along Highway from (1) km 226.100 to km 229.100 (2) km 261.950 to km 262.100 at the extreme edge of RoW using open trench method.
- Crossing at (1) km 226.160, (2) 254.800 (3) 261.950, (4) 267.450 through HDD method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch.
