The proposal has been examined based on the Ministry's circular No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 and the details are as under:

- 2. The Right of Way in the stretch of NH proposed for laying 300mm HDPE pipe line is varying from 19.65m to 39.50m. The carriageway width of stretch from Km.307/605 to 308/725 of NH-948 is 7.00m. The AV HIFIELD OWNERS WELFARE ASSOCIATION has proposed to lay the underground Public Utility at edge of the ROW for a length of 1120m by adopting open trench method.
- 3. The AV HIFIELD OWNERS WELFARE ASSOCIATION, has furnished an undertaking to the effect that they will remove the laid Public Utility pipe line in future if required by NH wing of Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, AV HIFIELD OWNERS WELFARE ASSOCIATION will also restore the ROW surfaces to its original condition soon after removal of the Public utility pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
