It is to inform all concern that M/s Maharashtra Jivan Pradhikaran vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Amravati has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s Maharashtra Jeevan Pradhikaran along on Nagpur to Amravati section at km 18.100 to 22.300 and crossing at km. 22.300 on NH-53 in the State of Maharashtra is as follows:

- Underground Water Supply pipeline laying from Design km. 18.100 to km. 22.300 in utility corridor & crossing 01 nos. At ch.22.300 in Nagpur to Amravati section of NH-06.
- Laying water line at edge of ROW, in utility corridor from Design km 18.100 to km 22.300 by Open trenching method and Crossing at ch. 22.300 with carried out by HDD/Push Through Method.
- Water line to be laid in Duct 1.2m below ground level in both method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch.
