

- 2. The alignment proposed by that M/s Bharti Airtel Limited along on Nagpur-Bhandara section at km 543+300 to 541+300 on NH-6 in the State of Maharashtrais as follows:
 - Underground Telecom Cable at km 543+300 to 541+300 on NH-6.
 - Alignment of the cable is along Nagpur-Bhandara section on NH-6
 - Cable to be laid in Duct 1.65m below ground level.
 - Cable to be laid by HDD method
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
