- The alignment proposed by GAIL's is for crossing 24" Diameter Gas Pipeline 2. and OFC Cable across NH-161 at km 51+140 (NH-161 Road Chainage) and Km 459:193 (Pipeline Chainage) falling en-route Mumbai to Nagpur Pipeline in Washim District. The following work is included:
  - To cross 24" gas pipeline and OFC Cable on NH-161 at km 51+140 (NH-161 Road Chainage) and Km 459.193 (Pipeline Chainage) through HDD Method.
