Sub: NHAI, RO Chennai - PIU, Salem - Proposal for laying of water pipeline along the road from Km 70/800 to Km 81/405.50 (RHS), Km 70/800 to km 71/200 (LHS), Km 75/000 to Km 76/664 (LHS), Km 78/200 to Km 78/400 (LHS), Km 79/300 to Km 79/500 (LHS), Km 80/500 to Km 80/800 (LHS), Km 81/000 to Km 81/405.50 (LHS), Km 85/687 to Km 86/313 (LHS), Km 90/114 to Km 90/514 (LHS & RHS), Km 94/620 to Km 94/920 (LHS & RHS), Km 100/120 to Km 100/620 (LHS & RHS) and across at Km 71/200, Km 76/050, Km 78/200, Km 79/500, Km 80/500, Km 81/405.50, Km 85/687, Km 90/114, Km 94/620 & Km 100/120 by HDD Method of NH-47 - CWSS to Perundurai and 7 Other Town panchayath including 547 wayside Rural Habitations to Erode and Tiruppur Districts by the Executive Engineer, TWAD Board, Project Division, Kangeyam, Erode-Reg.

The proposal is regarding permission sought by the Executive Engineer, TWAD Board, Project Division, Kangeyam, Erode seeking permission for laying of water pipe line along the road from Km 70/800 to Km 81/405.50 (RHS), Km 70/800 to km 71/200 (LHS), Km 75/000 to Km 76/664 (LHS), Km 78/200 to Km 78/400 (LHS), Km 79/300 to Km 79/500 (LHS), Km 80/500 to Km 80/800 (LHS), Km 81/000 to Km 81/405.50 (LHS), Km 85/687 to Km 86/313 (LHS), Km 90/114 to Km 90/514 (LHS & RHS), Km 94/620 to Km 94/920 (LHS & RHS), Km 100/120 to Km 100/620 (LHS & RHS) for a length of 16,401 meters and across at Km 71/200, Km 76/050, Km 78/200, Km 79/500, Km 80/500, Km 81/405.50, Km 85/687, Km 90/114, Km 94/620 & Km 100/120 by HDD Method in Kumarapalayam to Chengapalli of NH-47 in the State of Tamil Nadu submitted to this office by the PD, NHAI, Salem vide letter No. NHAI/PIU-SLM/Water pipeline/2019/2225 dated 14.12.2019

2. Executive Engineer, TWAD Board, Project Division, Kangeyam, Erode has proposed the following width of pipe as under duly keeping top of the casing at a depth of 1.65m below the ground level with the available width of ROW as 60m (30m + 30m):

150 mm dia DI water supply pipe encased in 300 mm dia MS casing pipe and the top of casing is proposed across the road at Km 71/200, Km 76/050, Km 78/200, Km 79/500, km 80/500, Km 90/114 & Km 94/620.

400 mm dia DI water supply pipe encased in 700 mm dia MS casing pipe and the top of casing is proposed across the road at Km 81/404.50

200 mm dia DI water supply pipe encased in 400 mm dia MS casing pipe and the top of casing is proposed across the road at Km 85/687

300 mm dia DI water supply pipe encased in 700 mm dia MS casing pipe and the top of casing is proposed across the road at Km 100/120.

3. The submitted proposal is in conformity with Ministry's latest guidelines, regarding accommodation of public and industrial utility services along and across National Highways, issued vide letter dated 22.11.2016.


4. Executive Engineer, TWAD Board, Project Division, Kangeyam, Erode has has given undertaken to adopt HDD method for crossings of all cross roads at Grade Separators, at grade junctions and wherever required and in the built up areas as per the instruction of NHAI Officials. Further, it is undertaken to that they will shift the pipeline due to 6-laning/widening within time fixed by NHAI. Executive Engineer, TWAD Board, Project Division, Kangeyam, Erode has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/27/2005-S&R dt.21.09.2010 as when asked by NHAI.

5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, TWAD Board, RWS Division, Karur will be made available for 30 days for public comments/objections and the comments are to be furnished within 30 days from the day of closure.
