

Sub: Four laning Madhya Pradesh / Maharashtra Nagpur section of NH-7 from km.652.00 (New km 653.225) to km.729.00, including construction of Kamptee – Kanhan & Nagpur Bypass and Maintenance of already 4 landed section from km.14.585 to km.36.600 NH-7 (Nagpur-Hyderabad Section) in State of Maharashtra under NHDP Phase-II on DBFOT Basis – Permission of laying of underground HT electrical cables and Overhead Lines along NH starting from km 542+800 to km 544+200 & 01 No. Crossing at km 543+000 of NH-53 (Nagpur – Bhandara Road) and also from km 725+600 to km 722+250 & 01 No. Crossing at km 722+250 of NH-44 (Jabalpur –Nagpur section) -Reg.

It is to inform all concern that M/s Harrshiv Healthy Foods & More Pvt. Ltd. vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU-1, Nagpur has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that M/s Harrshiv Healthy Foods & More Pvt. Ltd. is along NH-53 from km 542+800 to km 544+200 & 01 No. Crossing at km 543+000 (Nagpur Bhandara Road) and also from km 725+600 to km 722+250 & 01 No. Crossing at km 722+250 of NH-44 (Jabalpur –Nagpur section) is as follows:
 - Underground / Overhead line 33 KV line to be laid from km 725.600 to km 722.250 (LHS) & 01 No. Crossing at km 722+250 on NH-44
 - Underground / Overhead line 33 KV line to be laid and from km 542+800 to km 544+200 (RHS) & 01 No. Crossing at km 543+000 on NH-53
 - Cable to be crossed by HDD method.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
