Invitation of Public Comments

SUB: Six-laning of Surat-Dahisar section of NH-8 from Km 263+000 to Km 502+000 (Length Km 239+000) in the state of Gujarat and Maharashtra executed as BOT (Toll) on DBFO pattern NHDP Phase-V. Reg. Proposal seeking ROW permission for pushing and laying RCC Hume Pipe crossing at (i) Km 500+210 near Sai Palace Hotel and (ii) Km 498+210, Sahyadri Hotel, Village-Varsova, for delivering Water from Rajiv Gandhi National Park Mira-Bhayandar Municipal Corporation for fast discharge purpose, so that in heavy rainfall, water logging not occurs in the state of Maharashtra.




