It is to inform all concern that M/s Reliance Jio Limited vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Nagpur 1 has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that M/s Reliance Jio Limited along on Saoner Dhapewada Kalmeshwar Gondkhairi section at km 4.700 to km 33.575 on NH-547E in the State of Maharashtra is as follows:
 - Underground Optical Fiber Cable from km. 12.100 to km. 13.100
 - Alignment of the cable is along Saoner Dhapewada Kalmeshwar Gondkhairi section at km 4.700 to km 33.575 on NH-547E.
 - Cable to be laid in Duct 1.65m below ground level.
 - Cable to be crossed by HDD method at km 65/00.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
