It is to inform all concern that M/s Telesonic Networks Ltd. vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Dhule has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by M/s Telesonic Networks Ltd. for permission for trenching and laying OFC cables along NH-03 and crossing. The following work is included:
 - Laying of underground Optical Fiber Cable from km. 238.600 to km 239.300, km 239.300 to km 242.500 & km 255.600 to 256.700.
 - Cable to be laid along highway in trench in utility corridor.
 - Cable to be crossed by HDD method at kn. 255.600 & km 239.300.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
