

Sub: Proposal for grant of permission for laying Pipeline in Jalswaraj Tappa-2 Wajegaon Water Supply Yojana Tq. Nanded at Ch. Km. 207.70 to ch. Km. 208.00 of total length 300 m. And one crossing at ch. Km. 208.000 across NH-361 of Village Wajegaon, Tq. & Dist. Nanded.

It is to inform all concern that M/s Maharashtra Jivan Pradhikaran vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Nanded has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that M/s Maharashtra Jeevan Pradhikaran along on Loha-Waranga section at km 207.70 to km 208.00 and crossing at km. 208.00 on NH-361 in the State of Maharashtra is as follows:
  - Underground Water Supply pipeline laying from Design km. 207.70 to km. 208.00 in utility corridor & crossing 01 nos. At ch.208.00 in Loha to Waranga section of NH-361.
  - Laying water line at edge of ROW, in utility corridor from Design km 207.70 to km 208.00 by Open trenching method and Crossing at ch. 208.00 with carried out by HDD/Push Through Method.
  - Water line to be laid in Duct 1.2m below ground level in both method.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch. The objections / comments may be addressed to the below mentioned address upto 23.04.2021, beyond due date, no comments/ objections will be accepted
