Proposal for ROW permission for laying 66KV U/G Cable line with 630 sqmm XLPE Power Cable for 66KV S/C (3+1) UG cable laying work from 66KV Bhimrad S/S to 66KV Diamond Burj Surat S/S, crossing to NH-53 at Km 27+290 and Parallel from Km 27+140 to Km 27+290 in the state of Gujarat.
