It is to inform all concern that the Chairman, M/s. 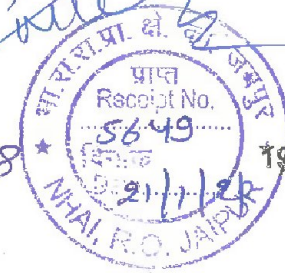


Sir,
