# <u>Check list for getting approval for laying of underground cable pipeline (33KV,185 sq</u> mm. 3 core HT cable ) on NH land.

The permission for laying of underground cable pipeline shall be considered for approval/ rejection based on the Ministry Circulars mentioned as above.

(a) Carrying of underground cable pipeline on highway bridges shall not be permitted as furmes/ underground cable pipe can be accelerate the process of corrosion or may cause explosions, thus being much more injurious than leakage of water.

(b) Services are not being allowed indiscriminately on the parapet/ any part of the bridges, safety of the bridges has to be kept in view while permitting various services along bridge. Guidelines for processing the proposal for laying of utility line in the land along national Highways/ Expressway vested with NHAI/PWD/BRO.
