SUB: Short Term Improvements & Routine maintenance of Surat-Vapi section from Km 263.000 to Km 381.000 on NH-48 in the state of Gujarat

- Proposal seeking ROW permission for laying and crossing of 140mm/160mm Diameter PVC Pipe 250mm Diameter MS Pipe, 300mm Diameter Pipeline Trench underground Water Pipeline (i) laying along from Km 316+150 to Km 316+350 (LHS), (ii) Km 316+350 to Km 317+000 (RHS) and (iii) across NH-48 at Km 316+350, Village-Hond, Taluka-Chikhali, District-Navsari, in the state of Gujarat for the Gujarat Water Supply & sewerage Board for Drinking water supply Under Chikhli Amandhara RWSS, in the state of Gujarat.


