SUB: Proposal seeking ROW permission for (i) 66KV S/C Gondal (220KV)-KSS line & 66KV S/C Gondal-Hadamtala Underground Cable laying between Km 145+200 to Km 146+200 on RHS and crossing at Km 146+200 and laying from Km 146+200 to Km 152+550 on LHS under the Kishan Suryoday Yojna scheme of GOG in the state of Gujarat.
