Subject:- Permission proposal for laying underground Water supply pipeline across road at Km 03/610 by HDD trenchless method on NH-87(Madurai Dhanushkodi Road) in the state of Tamil Nadu - Reg.

The proposal is regarding request for permission to lay underground Water supply pipeline across road at Km 03/610 by HDD trenchless method on NH-87(Madurai Dhanushkodi Road) in the state of Tamil Nadu by the Chief Engineer, Madurai Corporation, Madurai submitted to this office by the SE (NH), Madurai vide letter No. 1415/2024/JDO-1/ dated 21.06.2024. The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying Water pipe line is 22.00m. The carriageway width of stretch at Km 03/610 on NH 87 is 17.79m, The Chief Engineer, Madurai Corporation, Madurai has proposed to lay the underground water pipeline by HDD method across the National highway at Km.03/610 at a depth of 2.00m from the top of subgrade.

3. The Chief Engineer, Madurai Corporation, Madurai has furnished an undertaking to the effect that they will remove the laid Public Utility water pipe line in future if required by NH Authority/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH Authority/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Chief Engineer, Madurai Corporation, Madurai will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.


